## Tips

**Pricing** – We allow either "LOCK" or "FLOAT".

Loan product selection must be made at time of loan submission.

**Delivery** – Visit the Lakeview Correspondent <u>website</u>.

- Select <u>Non-Delegated Underwriting Portal</u> to upload the complete <u>credit package</u> for review (initial submission, underwriting, uploading conditions through clear to close).
- Select Delegated/Closed Loan Portal to upload the <u>closed loan</u> <u>file</u> (pre-purchase review, conditions through purchase).

#### **Initial Loan Submission**

- Complete and upload Product Specific Loan Checklist
- Upload all applicable required documents on product specific checklist
- Include any notes or comments that will assist the underwriting with rendering a decision

#### **Exception Requests**

- Complete the <u>Exception Request Form</u> located on the <u>Non Delegated Forms</u> section of our website for loans that do not meet guideline eligibility requirements.
- Upload the completed form along with initial file submission.
